Overview

I am a Social Psychology Program Director for the National Science Foundation, on leave from Miami University. My research explores how relationships with families and pets improve health and well-being, how self-nature representations promote environmental sustainability, and how people form impressions of others, supported over the years by NSF, NIMH, and NICHD grants. I have served as Editor in Chief or Associate Editor for three top scientific journals, president of two scholarly societies, and chair of a large academic department (e.g., 1200 majors, 60 doctoral students, 40 faculty and direct reports). Finally, I teach undergraduate and graduate courses in social psychology, well-being and resilience, sustainability, intergroup relations, and attitudes.
